Hello all. I am hoping all is well. I have a few things to report on that have been in the works. First of all, the electrical outlets in the dry storage and power to the Smith House should be good now. Thanks to our friend Kody Corduan. We are in the process of getting the missing piling replaced between east wet slips 17 and 15. Along with this, we are getting the wobbly piling behind slip 23 replaced.

I recently sent out the current slip leases to members with boats in dry and wet slips. There has been a great response to this in the past week. I thank you all. However, there are many more to go. We have asked that these are in by the All Hands Meeting this Thursday. We will have some forms on hand then, if anyone wants to fill them out at that time.

As far as dry slips, we are still full with 6 on the waiting list. There is a small chance that one or two may open soon. As for the wet slips, we are full on the west side, with one waiting. For the east side we have slips 5 and 7 available. Of course all of the transient slips are available. As far as the Cat Beach, and Sunfish area, if you see room to safely store your boats there, then do so and let us know, fill out a lease and provide insurance.

I would like to ask something of the folks in dry storage and those who use the transient trailer parking lot. When you launch your boats, please put your trailer back in your assigned dry slip, disconnect your vehicle and park it in the main parking areas. Those who launch their boats and park their vehicles and trailers in the upper trailer parking lot need to back as far as they can against the bumper pilings laying on the ground to ensure that others can navigate safely when parking or retrieving their trailer.

Well lastly, we are coming into the peak Hurricane season. Please be prepared to evacuate the marina and possibly dry storage when needed. We will try to issue the notice many days in advance. Please let us know if you are in need of assistance in doing this.

Well that's it for me. Thank you to the great staff for being so awesome! As always, please let me know if I can be of any assistance.

### NOTICE OF AMENDMENT OF BYLAWS

Motion was made at the July 15, 2024 GLYC Board meeting to remove the statement in Article III, Section 3 of the Grand Lagoon Bylaws to allow Board members to vote in absentia. (see highlighted text that is subject to removal)

The Board will meet at least once each month at a regular time to be fixed by the Commodore and at such other times as the Commodore will direct. All members of the Board will be notified of all meetings. A quorum of fifty percent (50%) plus one (1) present will be required to have a regular or called meeting of the Board. ~~A board member can vote via conference call if they cannot attend the meeting in person.~~ The Commodore or presiding officer will vote only in the case of a tie at any meeting. Although general members may be present at the Board meetings, they will not be allowed to enter into the Board's discussions during the meeting. Members wishing to address the Board may do so during the first fifteen (15) minutes of the regular monthly Board meeting. The member must contact a Flag officer at least twenty-four (24) hours prior to the Board meeting, advising the officer of the subject matter. Committee chairmen, or their designate, may address the Board when requested by the presiding officer.

**This motion to amend Article III, Section 3 of the GLYC Bylaws will be voted on at the next GLYC Board meeting on August 27, 2024.**

# House Rules for Grand Lagoon Yacht Club

---

The Grand Lagoon Yacht Club (The GLYC) and all the facilities of The GLYC are primarily for the use, entertainment, and enjoyment of the members and their families and guests. The House Rules of The GLYC are designed to facilitate and promote this purpose. The House Rules and any additions thereto are established and may be revised by the Board of Governors subject to the direction and approval of the Board of Governors. Members should be aware that:

- These rules are enforceable by any Board Member, Manager or Flag Officer present.
- Delinquency in financial obligations will result in denial of club privileges and possible expulsion from The GLYC.
- Any complaints, requests, or suggestions must be directed to the Board of Governors in writing.
- Violations of any of the rules will result in action by the Board of Governors concerning the member(s) will be allowed a hearing and the Board of Governors' action may be appealed. However, if the member(s) in question is on the Board, he/she will not be allowed to vote in the appeal.
- Rules will be posted at all times.

## **HOUSE RULES** (revised 2/25/2024)

1. Members are responsible for signing in their non-member guests. The GLYC member shall be responsible for the guest's conduct, and the guest shall leave when the member leaves The GLYC.
2. Non-members that are not the immediate family of a member and live within 50 mile radius of the Club will be allowed in the Club no more than ten (10) times per year. Members of other reciprocal yacht clubs, providing proof of membership, are not considered guests. Transients temporarily renting a slip are allowed access to the club during the rental period. Frequent guests will be encouraged to join the club. When a violation is brought to the attention of the Board, the guest book will be reviewed by two Board members and action will be taken.
3. Prior members who have resigned from The GLYC and were not in good standing cannot be a guest of another member.
4. A person whom a member is dating is considered a guest, but the date may use the facilities of The GLYC as often as the date is accompanied by the member, provided that the date abides by all the rules and regulations of The GLYC.
5. Be appropriately dressed while in the Club. No bathing suits, tank tops, or bare feet in the Club. Be at least casually dressed in good taste during the dining room hours.
6. Observe current opening and closing hours.
7. Refrain from offensive language, conduct, or intoxication. If offensive, a member may be asked to leave the premises by The GLYC management or Flag Officer and is expected to do so at once.
8. Refrain from going behind the bar, entering the galley during operation, or otherwise interfering with bar/galley functions.
9. Purchase all alcoholic beverages to be consumed on premises from the bar.
10. Be accountable for the conduct of your children. Children are not allowed at the bar other than the service station and must leave the area immediately after purchase.
11. Refrain from littering on the premises.
12. Members are accountable for their pets and their conduct; they must be on a short leash and in designated areas: downstairs, parking lot, east-side of upper deck.
13. Do not take club property (eg. Glassware, china, silverware, etc) beyond the dock.
14. Refrain from smoking, including e-tobacco products, "vaping," or use of all other tobacco products inside the club house.
